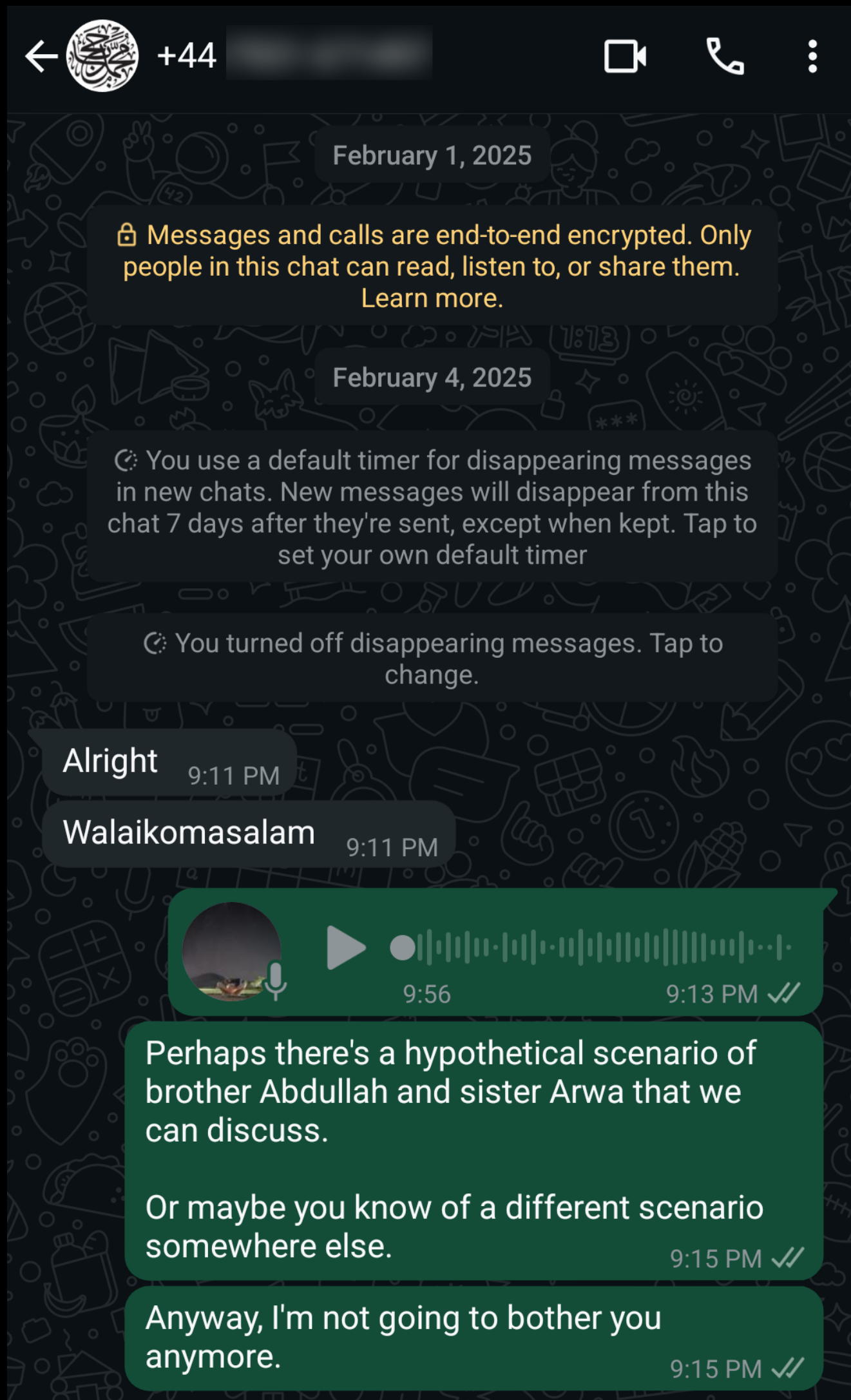

This document contains the full collection of **private** text message exchanges between Mohammed Hijab and Dr. Abu Ayah concerning the case of Sister Aisha and the allegations of deception and harm, via a secretive marriage, involving Mohammed Hijab.

Note: The conversation was initially kept confidential to allow Mohammed Hijab a safe and private space to speak openly. Dr. Abu Ayah was attempting to resolve the matter discreetly and avoid any public exposure.

Mohammed Hijab shares a photo of his child in a secure and single-view message.

Inserting his child into the interaction introduces a psychological "shield" where any future criticism might feel like it's not just targeting him, but potentially affecting an innocent party — his child

By insinuating that Dr. Abu Ayah is projecting unrelated issues onto him, Hijab attempts to pre-frame the narrative, placing Dr. Abu Ayah in a position where he may feel compelled to defend his intentions before the actual issue (the allegations) is even addressed

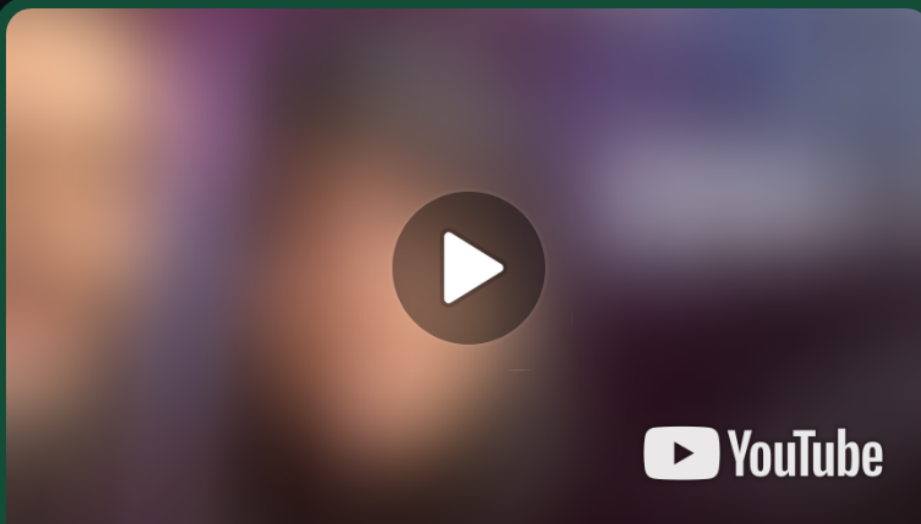

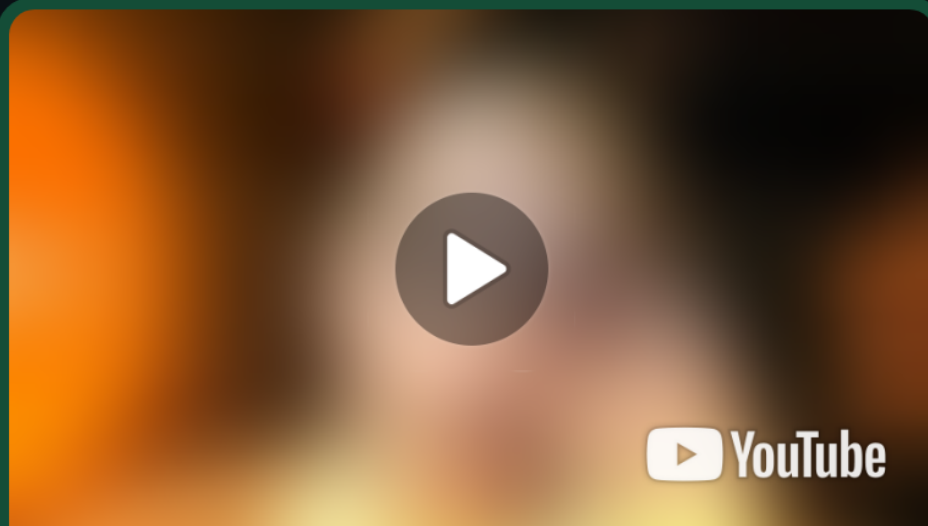

This is manipulative theatrics. Swearing oaths of death or invoking divine punishment is a strategy used to pretend sincerity, shut down skepticism, and intimidate the audience into believing a statement without scrutiny.

It is important to note, this is not a formal Mubāhalah (a mutual invocation of God's curse upon the liars; used in Islam when two parties cannot resolve a dispute and seek divine judgment).
