



This document contains a collection of text messages from a WhatsApp group called HPDawah. This invite-only group has existed for many years. It consists of 75 du'āt, primarily from the UK, but also includes others from around the world. The messages selected for presentation relate to the case against Mohammed Hijab and clearly illustrate deceit, along with collusion and complicity, by other colleagues and friends — including Ali Dawah.

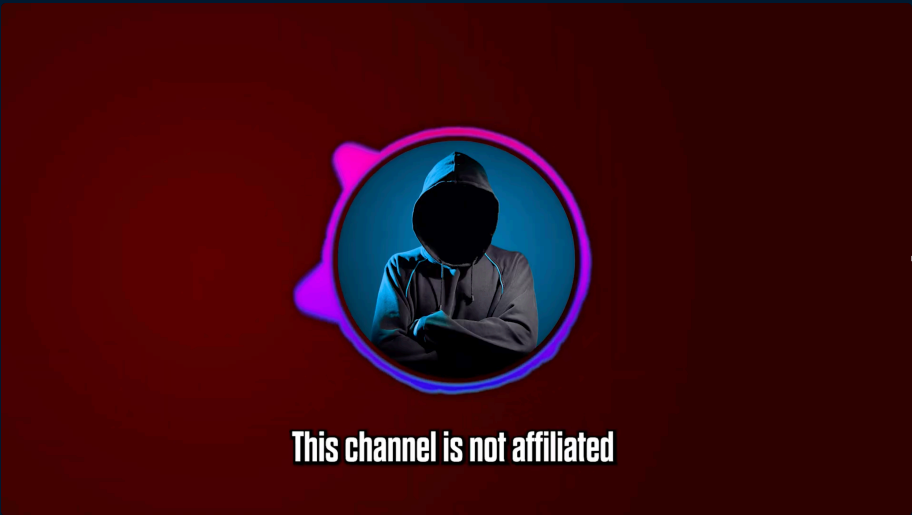

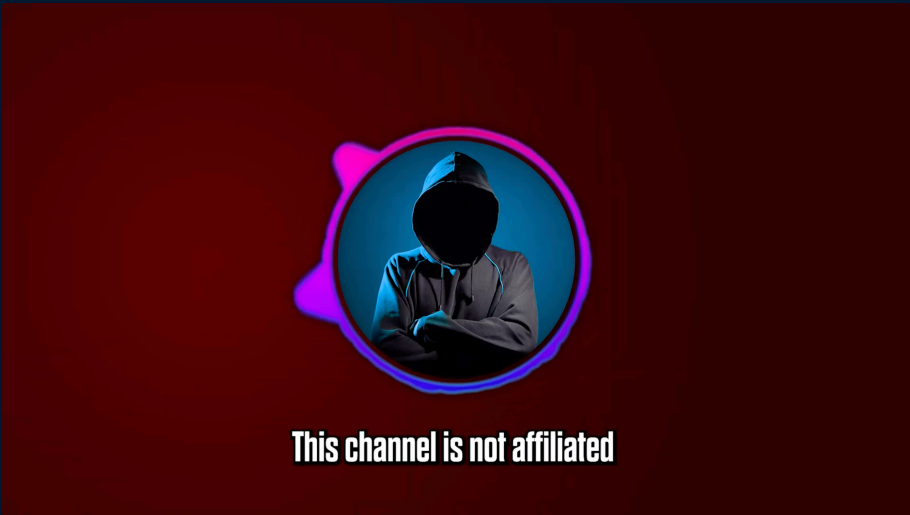
CONTINUATION OF LIES

Not even the life of an enemy.

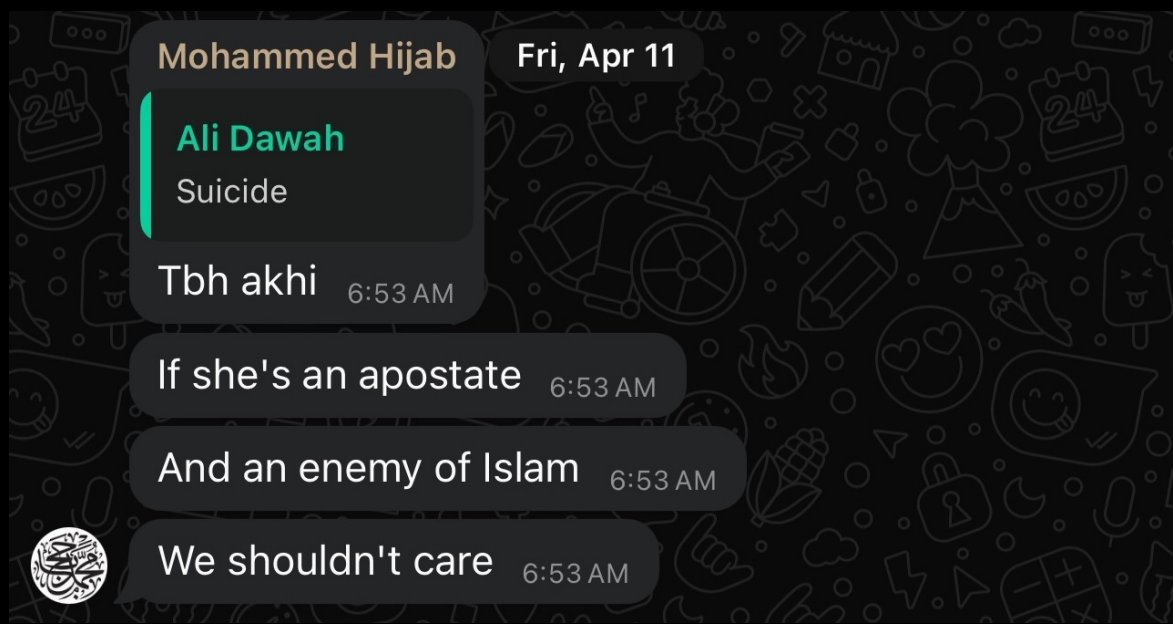
The Prophet ﷺ stood when a Jewish funeral passed by. Why?

Because **life** — any life — **is sacred**.

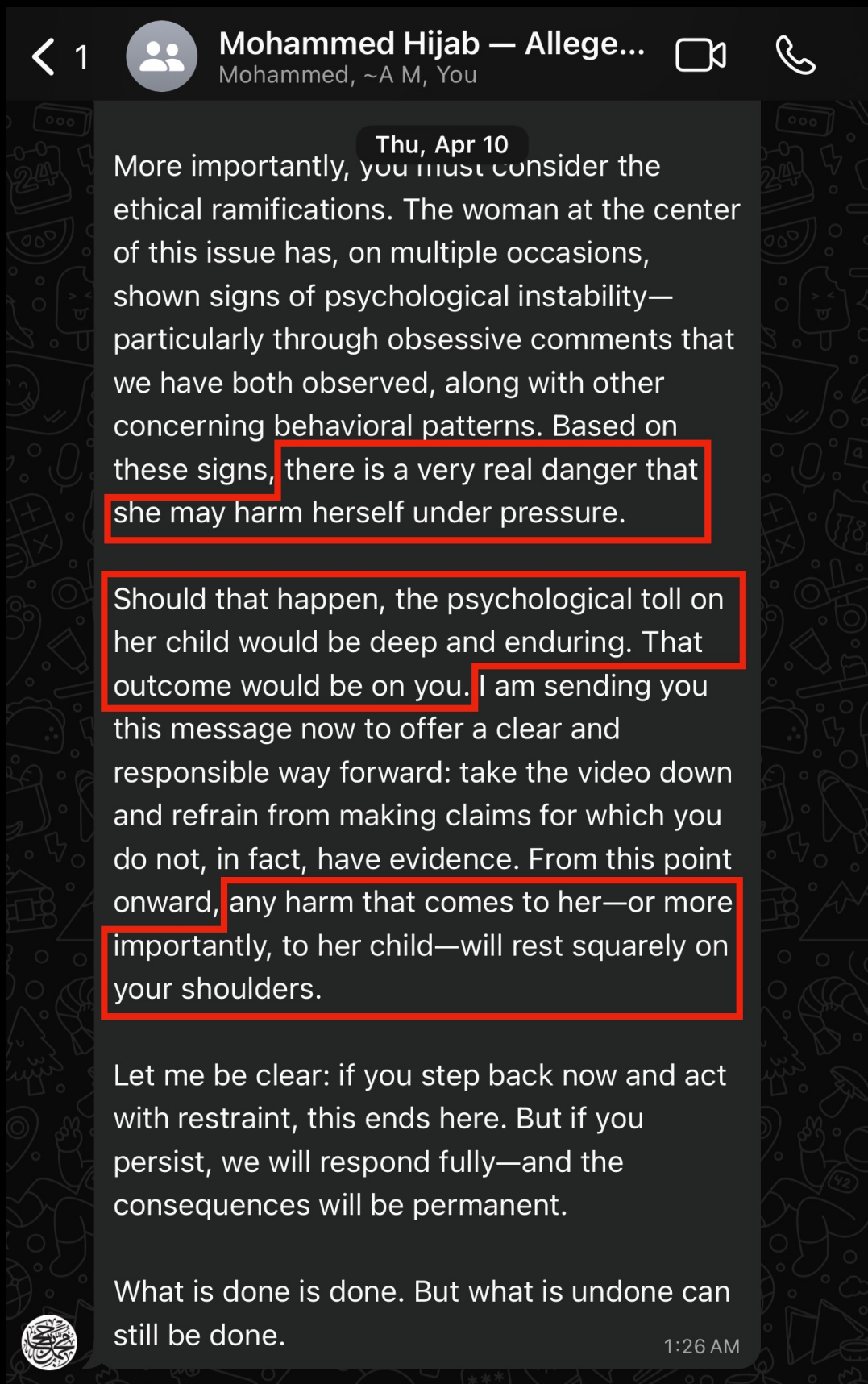

And the only enemy of Islam here is the one who speaks with such **cruelty** and **indifference**.



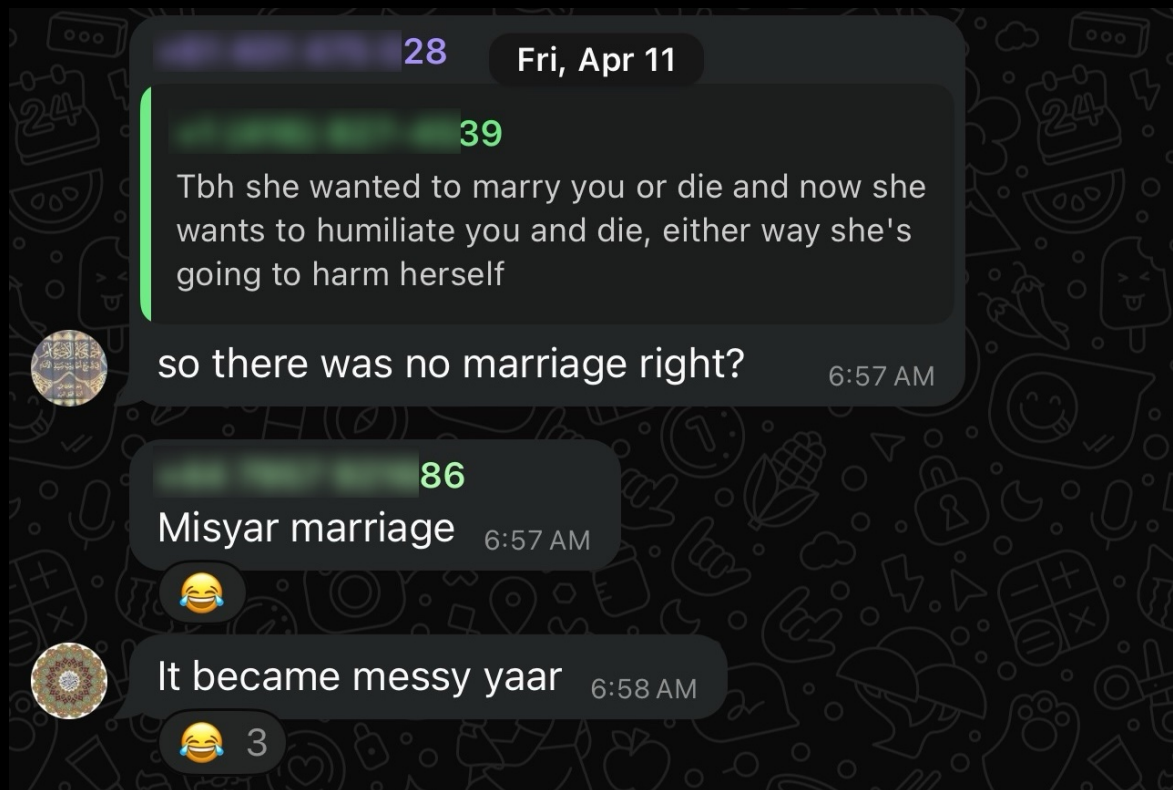
What adds to the shock is that NO ONE — **NOT A SINGLE DA'EE** — out of the 75 members of this group, expressed their dismay or disapproval to his **chilling response** — exuding the absolute and **complete disregard for human life**.



Just the PRIOR DAY, on April 10th, Hijab sent a message to Salman (Behind Veils) trying to infer that there is a “**very real danger that she may harm herself under pressure**.”

He explicitly conveys that if anything were to happen to her, the **liability**, for **both her and her child**, would be **on Salman**.

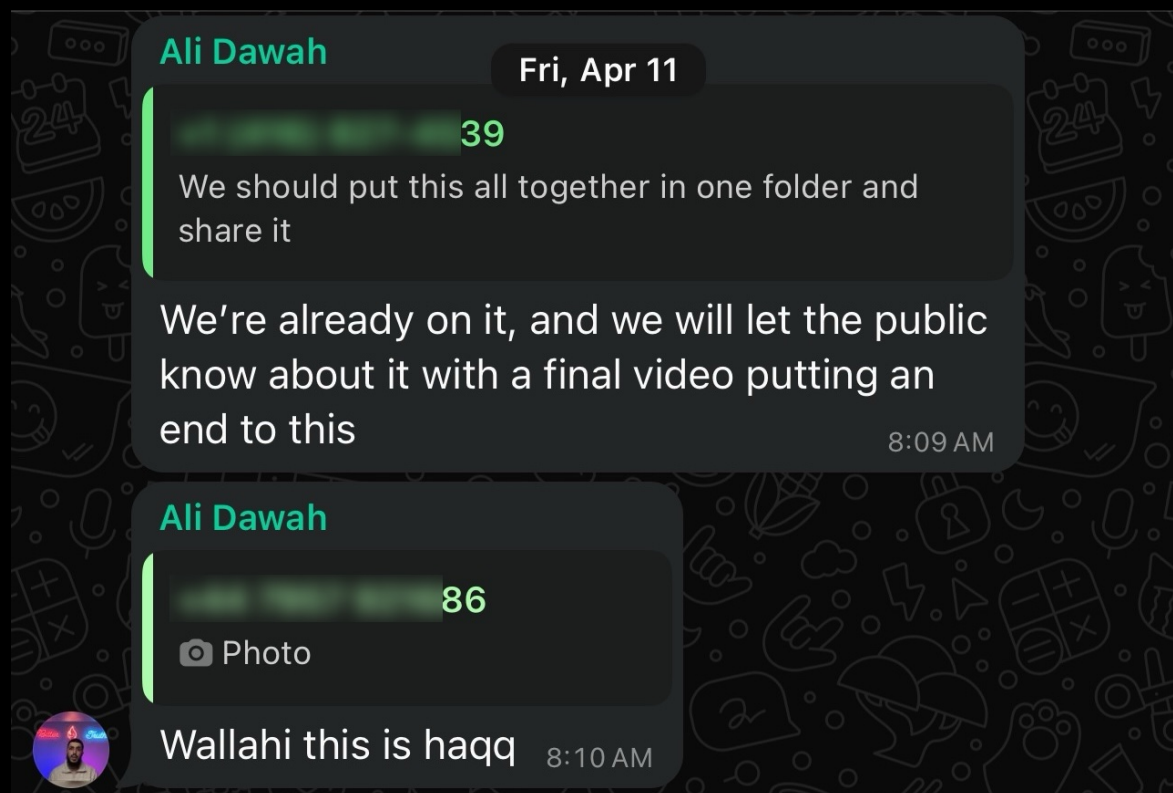
Hashim clearly states it was misyar marriage. And adds that it was a “messy” one.

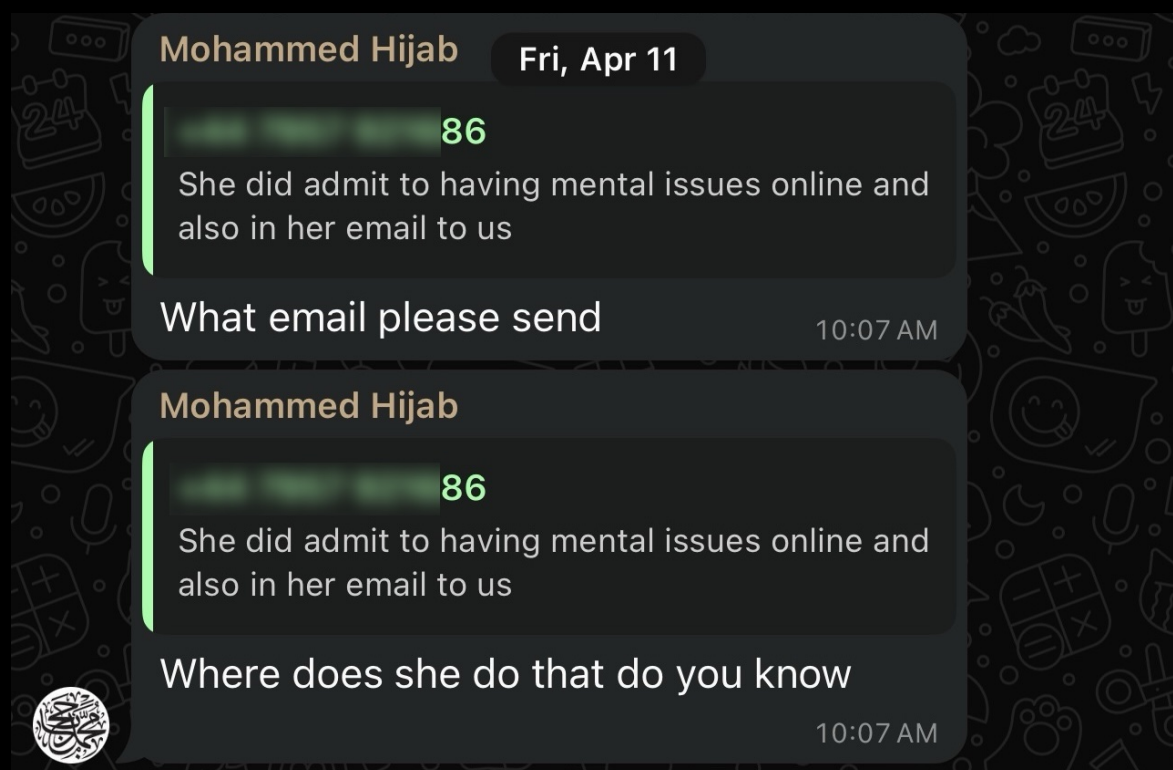

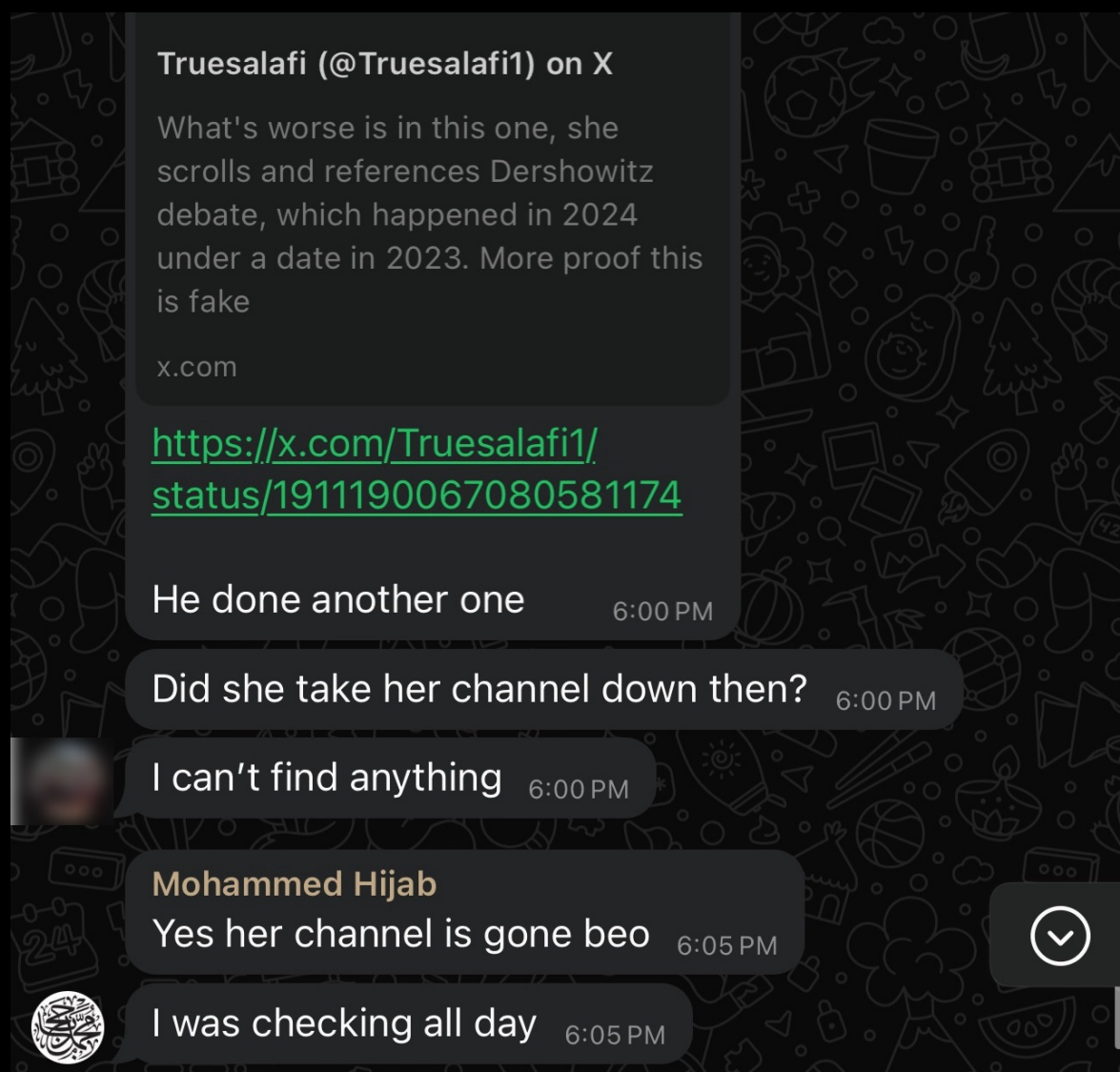
Ali Dawah clearly indicates his collaboration with Mohammed Hijab on the second and final video that he would eventually end up releasing on April 26th

Despite their knowledge, both Mohammed Hijab and Ali Dawah would continue making the public claim and emphatic assertion that there was NO MARRIAGE!

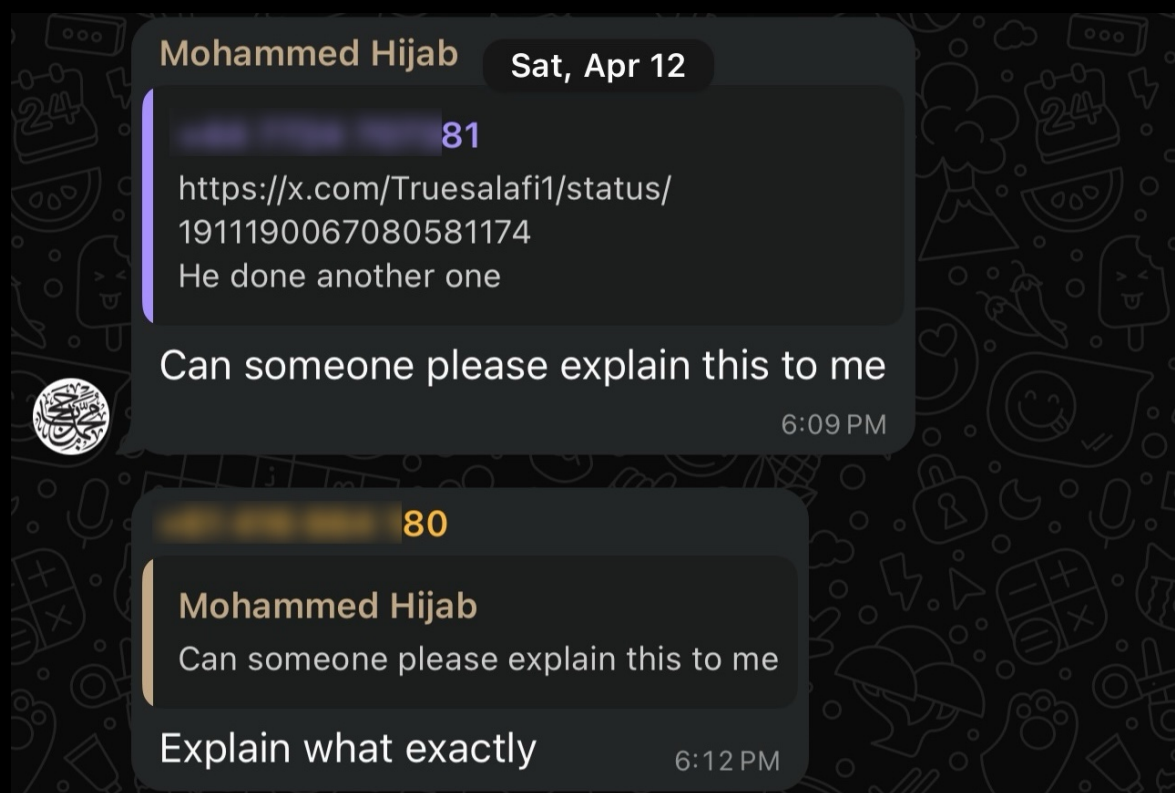

When Hijab realizes that it doesn't make any sense that someone else would know about his life and interactions better than himself, he reiterates the logic that was presented in the post on X

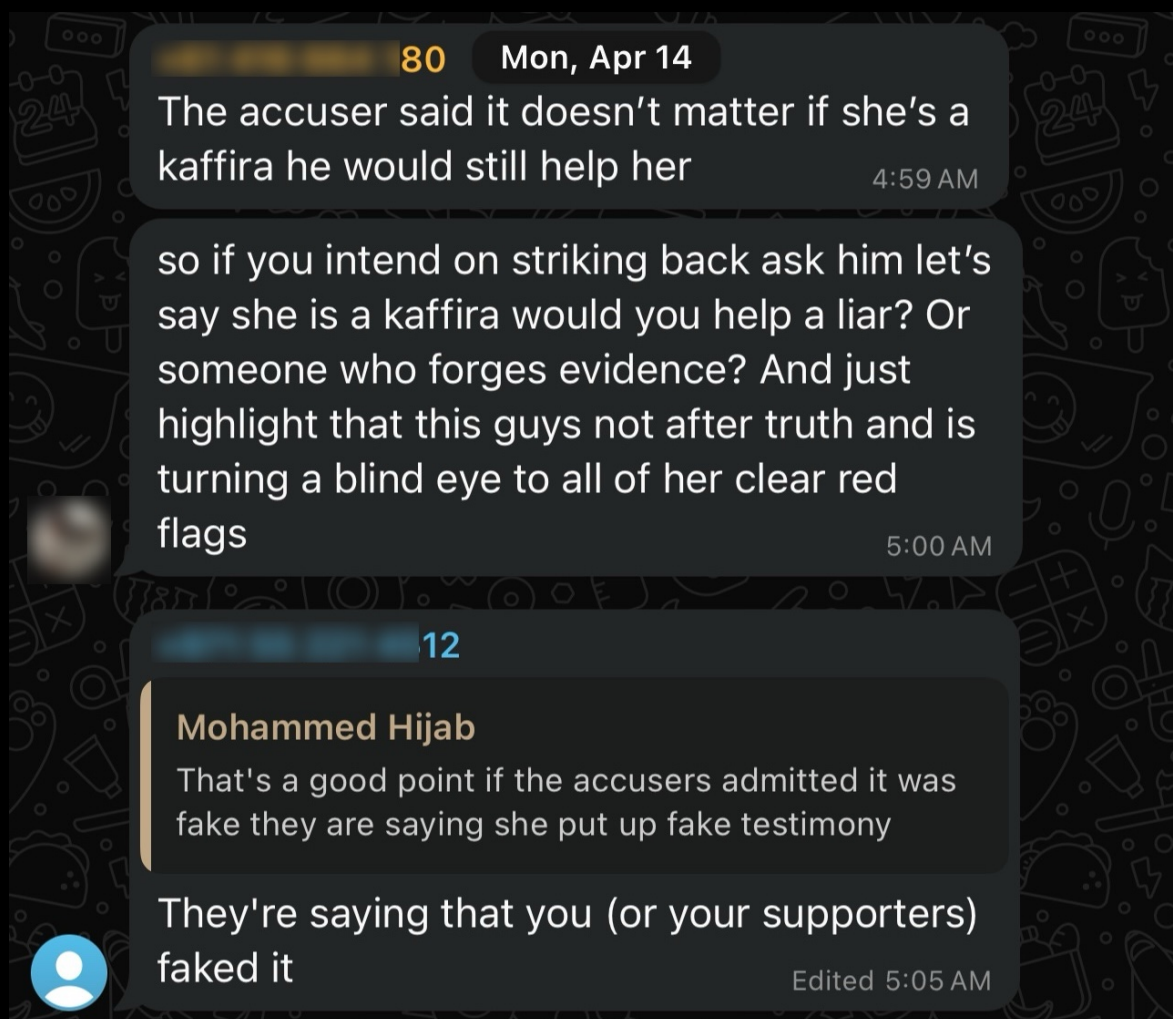


Once the logic is established by others in the group, Hijab reiterates why the screenshot would be fake, laughs it off, and no longer inquires about it

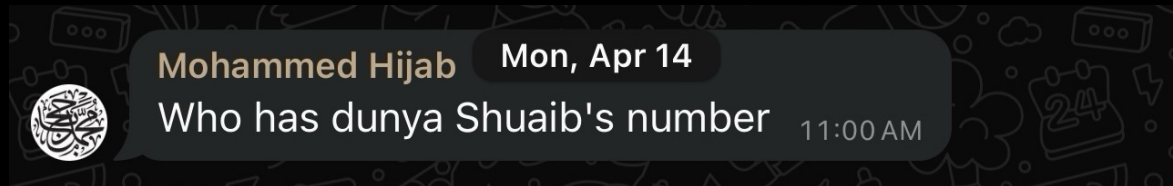
As a part of their collaboration on this group of 75 du'āt, they are collectively trying to find a way to discount and disqualify Behind Veils

When someone brings up the fact that Behind Veils has made an assertion that Team Hijab is behind faking these screenshots, Mohammed Hijab remains silent

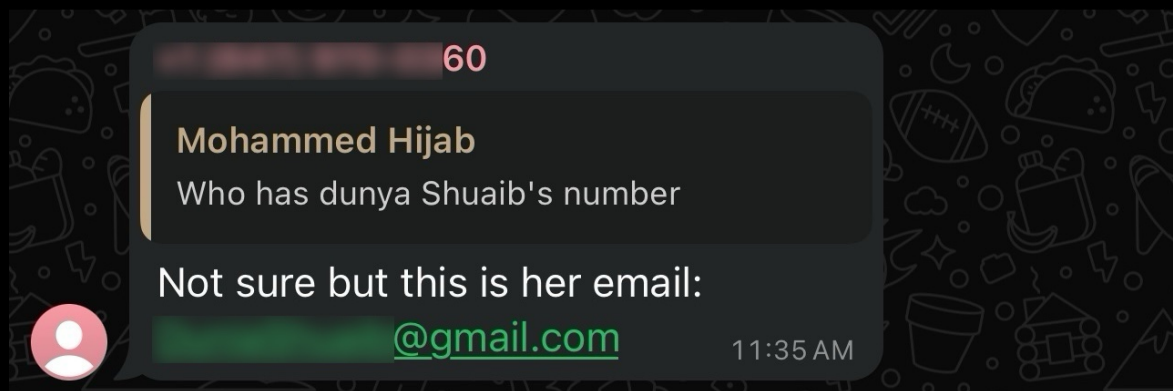
